Sir,

With reference to the subject cited above, I would like to inform you that Sapatgram College has received approval of RUSA Grants under RUSA 2.0 Component : Infrastructure grants to Colleges. Total Approved amount is Rs 2.00 crore (including Central Share and State share in the ratio 90:10) . As 1st instalment of grant, total amount released to the institution is Rs 1 crore . which will be utilized by the college on New Construction . Renovation and equipment purchase works as per the DPR submitted by the college and approved by RUSA Assam.

RUSA is a demand driven Scheme and as per guidelines, the RUSA Authority transfers the received amount with matching State share to the institutions. RUSA office is not responsible for floating of tender and issue of work orders. But the authority timely monitors the progress of works and also the organizations are to submit their UCs to RUSA Assam on time. Again in every organization, there is a Project Monitoring Unit under RUSA to monitor the execution of works at that particular institution.

Under these circumstances, the information regarding name of the work supervisor, engineer details , tender, quotation, specification of materials etc are not available with RUSA Authority. Therefore you are requested to kindly communicate with the College Authority for all above information.
